Exchange trades are held with different delivery times. Delivery terms are FCA warehouse of the consignor by road and DAP (border of the Republic of Belarus) by road or by railway. Sawn wood can also be sold on other delivery terms (CFR, DAT etc).

The products of our enterprises are environmentally friendly, meets the requirements of international and European standards. UE "Bellesexport" has FSC supply chain certificate FSC (FSC-C014390) and PEFC certificate.

In accordance with the legislation of the Republic of Belarus, sawn timber (commodity code 4407, 4401) is sold through exchange trades at the JSC "Belarusian Universal Commodity Exchange". A foreign buyer must participate in exchange trading to conclude an agreement on the supply of sawn timber.

Exchange trading is conducted according to the trading schedule, usually every week. Contracts at exchange auctions are concluded with different delivery periods - monthly, quarterly, semi-annual and annual.

The final price of forest goods is formed as a result of exchange trading. We also draw your attention to the fact that lots are put up for exchange trading in a range of sizes. After purchasing a lot and signing a contract, the Buyer indicates the specific size in his application according to the specified range of sizes in the purchased lot.
